### REQUEST FOR FILE-REVIEW PROCESSING

As per the *Instructions Governing the Streaming of Less Complex Claims at the Refugee Protection Division*, the Immigration and Refugee Board (IRB) is committed to adjudicating cases simply, quickly, and fairly. In order to reach this objective, claimants and counsel can request that a claim be reviewed and considered for potential processing under the file-review process, which means that a claim may be decided pursuant to paragraph 170(f) of the *Immigration and Refugee Protection Act* (IRPA) without a hearing. At any time prior to a decision being rendered, it can be determined by the RPD that a refugee claim will require a hearing.

The Refugee Protection Division (RPD) will not decide any claim without a hearing in the following circumstances:

- confirmation of front-end security screening has not been received;
- the Minister has filed a Notice of Intervention to intervene in person;
- A Notice has been sent under the RPD Rules notifying the Minister of a possible exclusion, inadmissibility or integrity issue;
- there are issues related to the claimant's identity which require further examination;
- there are serious credibility issues that arise from the documents in the file;
- the claim is inconsistent with country information; or
- there are complex legal or factual issues that require a hearing to resolve.

For a claim to be included into the file-review process, you must provide a reason below, which must include explanation on how the personal or documentary evidence and personal profile of the claimant(s) justify a decision without a hearing.

Please note that if your claim is processed through the file-review process, it does not mean that it will be finalized sooner.

This form should be sent to the RPD through one of the methods as noted in the [Practice Notice](#).

If your request is allowed, the claimant(s) will receive a letter with further instructions, which will also serve as a notification to the Minister that this refugee claim might be processed by the *Task Force on Less Complex Claims* (TFLCC) under the file-review process.

If your request is not allowed, the claimant(s) will receive a decision with reasons.
