



MACLUUMAAD MUHIIM U AH QOF DALBADAHA

Qoraalkan waxaa ku xusan macluumaad muhiim ah oo la xidhiidha ogeysiiska in lagu arko (Notice to Appear) ee aad heshey markii aad dalbatay magangalyada qaxootinimada. Waxaa kale oo ku xusan macluumaad dheeri ah oo muhiim ah lagaana rabo inaad si gaar ah u dheehato. Macluumaadkan oo isugu jira qoddobadan soo socda:

1. Waaad xaq u leedahay in aad qabsato qof ku matala, kaasoo kharashkiisa aad adigu iska bixiso. Waaana la rabaa in qofka ku matalaya uu soo xaadiro maalinta dalabkaaga (dacwadaada) la dhageysanayo oo aanu sina u maqnaan.
2. Waxay adiga mas'uuliyadeedu ku saaran tahay helitaanka, kadibna u soo gudbinta Hay'ada Magangalinta Qaxootiga (Refugee Protection Division) ee hoos timaada Hay'ada sare ee Socdaalka iyo Qaxootiga ee Kanada (Immigration and Refugee Board of Canada), wax alla wixii dokumenti ah ee la xidhiidha islamarkaana lifaaq u noqon kara dalabkaaga magangalyo ee qaxootinimo. Waana inaad raadinta dokumantiyadaas si degdeg ah u gudagashaa oo aadan sina ula daahin.

ARRIN KU SAABSAN OGEYSIISKA IN LAGU ARKO WAKHTIGA DHAGEYSIGA DACWADAADA

Waxaa dhacda in ogeysiiska in lagu arko uu kugu soo gaadho laba siyaabood midkood. Labadaas siyaabood oo kale ah sida ka muuqata tusaalayaasha hoose (F.G. eeg labada khaanadood ee hoos ku xusan). Tusaalayaashan ayaa u kala baxa sida xafiisyada ku yaal meesha aad ka soo gashey markaad is dhiibeysey iyo xafiisyada ku yaal wadanka gudahiisa ee aad iska dhiibtey adigoo wadanka dhex jooga. Waxaa marka hore muhiim ah inaad kala garato sida uu ogeysiiska in lagu arko ah uuu kugu soo gaadhay iyo meesha aad ka qaadatey (F.G. xusuuso ma dibada ayaad ka timid mise waddanka gudhiisaayaad joogtey markaad codsanaysey magangalyada qaxootinimo). Ka dib akhri qeybaha waraaqahan ka khuseeya nooca isdhiebkaaga, adigoo si gaar ah ugu feejigan maalmaha iyo wakhtiyada la xidhiidha nooca uu yahay ogeysiiska ah in lagu arko ee aad heshey.

MAALMO MUHIIM AH

Qoraal la xidhiidha guud ahaan Ogeysiisaya in La Arko Qofka

1 - **Maalinta la dhagaysanayo dacwadaa dalabkaaga qaxootinimo:** Maalintani waa maalinta **koowaad** ee ogeysiiska in lagu arko. Haddii ad imaan kari weydo dhageysiga dacwadaada sababo caafimaad, fadlan ka dhex fiiri qeybta *Claimant's Guide* (oo Af Soomaali ahaan u dhiganta Hagaha Qofka Dalabka Sameynaya) ee dokumentigan ka midka ah, waxa lagaa rabo inaad sameyo.

- Waxaad kartaa inaad soo kaxaysatid qof kale oo kaa caawiya markaad soo bandhigeysid codsigaaga. Qofkani wuxuu noqon karaa tusaale ahaan saaxiibkaa ama ethelkaa, balse waa in aanu qofkaasi sinaba u noqon qof lacag ama wax la mid ah kaa qaata si u kuu caawiyo marka ay dhageysanayo dacwadaada Qeybta Magangalinta Qaxootiga (ee marka la soo gaabiyoo loo yaqaan RDP). Waxaa kale oo aad ijaaran kartaa ama qabsan kartaa la taliye (counsel) ku matala.
- Waxaa daruuri ah, qofka aad ijaaranayso ama aad qabsanayso si uu kuula taliyo waa inuu yahay qof ka ah xubin sharaf leh hay' adaha kala ah Ururka Garyaaqanada Gobolka (garyaaqan iyo garyaaqano kalkaal), Rugta Ansaxinta ee Kubeek (Chambre des notaires du Québec) ama La Taliyaasha dhinaca Socdaalka ee Gudiga wax Toosinta Kanada (Immigration Consultants of Canada Regulatory Council). Qofka xubinka ka ah ururadan saddexda ah ayunbaa marka dacwadaada lagu dhageysanayo Hayada Magangalinta Qaxootiga haddii u ku matalo lacag kaa qaadan kara. Haddii aad go'aansato inuu lataliye ku matalo waa inaad ku talagashaa inaad kharashkiisa adigu bixinayso.
- Haddii aad go'aansato inaad qabsato ama ijaarato lataliye inuu ku matalo, waa inaad sidaa u yeeshaa si dhakhso ah oo aadan dib u dhigan. Haddii adan haysan kharash kugu filan oo aad ku bisixo lataliye waxaa kuu furan inaad la xidhiidhto xafiisika ka kaalmeeya dhinaca shuruucda dadka ee gobolka aad dagan tahay, si ay kuugu sheegaan haddii ay jirto gacan qabasho iyo meesha aad ka heli karto gacan qabashadaa. Waxaa la socda xidhmada-qoraal ee dalbadaha "Claimant's Kit" liis ka kooban xafiisaya xagga shuruucda ka kaalmeeya dadka.
- Haddii ad qof ka dalbato inuu ku kaalmeeyo marka la dhageysanayo dacwadaada, waa inuu qofkaasi soo xaadiraa oo u goobjoog ahaadaa maalinta dhageysiga dacwadaadu ay qoondeysantahay. Ugu yaraan waa inaad haysato la taliye, ama aad na soo wargaliso shan casho gudahood marka aad hesho ogeysiiska maalinta iyo taariikhda la dhageysanayo dacwadaada, hay'ad magangalinta qaxootigu (RPD) **sina** uma baddali doonto maalinta iyo taariikhda dhageysiga dacwadaada loo qoondeeyay haddiiba ay dhacdo inuu la taliyaahaagu soo xaadiri waayo. Waxa kale oo aanan la sameynayn in wakhtiga la badalo si la isu waafajiyoo wakhtiga dambe ee la heli karo lataliye la rabay inuu yimaado balse soo xaadiri waayey.

2 - **Maalintaada dhageysiga khaaska ah:** Maalintani waa maalinta labaad xaga ahmiyadda ee taxanaha Ogeysiiska Aragga (Notice to Appear) ee adiga ku khuseeyaa.

- Haddii lagu waayo oo aad iman weydo dhageysiga dacwadaada dalabka qaxootinimo maalinta ugu horeysa ee lagu sugayey, waxaad khatar galineysaa codsigaaga taaso laba xiri karo.
- Marka la dhageysanayo dacwadaada khaaska ah, waxaa lagaaga fadhiyaa inaad sharaxaad ka bixiso sababta aad u soo xaadiri weyday maalintii laguu qoondeeyey in la dhageysto dacwadaada magangalyada qaxootinimada.
- Haddii ay hay'ada magangalinta qaxootigu (RPD) ku qanciweydo cudurdaarka aad u sheegto, dacwadaada waa la xidhayaa waxaana lagu tirindoomaa inaad ka talo baxdey.
- Waxa kale oo laarkaa inay Hay'ada Magangalinta Qaxootigu (RPD) iskaba xidho dacwadaada iyadoon kula soo xadhiihdin, haddii aad soo xaadiri weydo maalinta dhageysiga dacwadaada khaaska ah.
- Haddii ay Hay'ada Magangalinta Qaxootigu (RPD) go'aamiso inaad ka tala baxdey dacwadaada dalabka magangalyada qaxootinimo, laguuma ogolaan doono inaad sii waddo dalabka aad markaa wadday sidoo kalena laguuma ogolaan doono inaad mustaqbalka sameyo wax dalab dambe ah.

HADDII AAD DALABKA MAGANGALYADA QAXOOTINIMO AAD KA SAMEYSEY MEESHII AAD KA SOO GASHEY DALKA (sida xuduudaha oo aad ka soo talowday, gagida divaaraadaha oo aad ka soo degtey, ama dakadaha oo aad markab kaga degtey), hawl-wadeen u qaabilan xafiiska Socdaalka avaa ku siivey xidhmo qoraalo ah oo dalbadaha loogu talagalay (ama Claimant's Kit)

Xidhmadan waxaa ka mid ah foom buuxin kaaga baahan oo la yidhaahdo *Basis of Claim* (Af Soomali ahaana u dhigma, waxa asaaska u ah inaad samayso codsi magangalyo qaxootinimo) iyo dokumentiyo kale oo la jira oo lagaaga baahanyahay inaad soo buuxiso inta ka horeysa taariikhda ku qoran Ogeysiiska Aragga (Notice to Appear) ee la xidhiidha maalinta loo qoondeyey dhageysiga dacwadaada qaxootinimo. Haddii Ogeysiiska Araga (Notice to Appear) ee lagu siiyey uu eg yahay kan ku xusan bogga koowaad ee dokumentigan qeybtii bidix, waxaa kale oo aad ku qasbantahay inaad ka taxadarto oo aad ilaalisoo labada taariikhhood ee la rabo inaad foomka "Basis of Claim" isagoo buuxa u dirto ama u gudbiso, Xafiiska Magangalinta Qaxootiga (RPD). Talaabooyinkan waa inaad qaaddaa oo aad dhameystirtaa adigoo ku dhameystiraya wakhitga hoos ku xaddidan gudhiisa, wakhtigan oo ah ka HOREEYA wakhtiga loo xaddiday in la dhageysto dacwadaada dalabka qaxootinimo.

3 - **Maalinta loo baahanyahay iney helaan foomkaaga magaciisu yahay "Basis of Claim" xafiiska Waaxda Magangalinta Qaxootigu (RPD):** haddii aad rabto inaad ogato maalinta lagaaga baahanyahay inuu foomkan "Basis of Claim" gaadho Hay'ada Magangalinta Qaxootiga (RPD), waxaa tirsataa ilaa shan-iyotooban maalmood kuwa kalendarka ah adigoo ka soo bilaabayaa tirsiga maalintii uu foomku ku soo gaadhay. Haddii maalinta lagaa rabo in foomkaaga la helo (waa shan-iyotooban bari ka dib maalintaad heshaye) ay ku soo hagaagto maalmaha aan la shaqeeyeyn sida Sabti, Axad ama Ciidaha wadanka ee ay xafiisaydu xidhanyihiin, waxay maalinta lagaa rabo noqonaysaa maalinta ku xigta maalintaas ee shaqooyinka lagu bilaabo Xafiiska Magangalinta Qaxootiga (RPD).

- Waa inaad xaqiijisaa iskana hubisaa inaad ku lifaaqdey codsigaaga dhamaan dokumentiyada kabaya dalabkaaga. Qeybta ku saabsan sida loo sameeyo dalabka ama "Claimant's Guide" (oo af Soomaali ahaan u dhiganta Hagaha Dalbadaha), aya waxaa ku xusan dokumentiyada lagaa rabo inaad soo raaciso foomka "Basis of Claim"
- Hadaadan wakhtigan xaadirkha ah haysanin dokumentiyada lagaa rabo, waa inaad raadintooda hadda bilowdaa oo aadan dib u dhigan si ad degdeg ugu hesho.
- Waa inaad foomka "Basis of Claim" lugahaaga adiga laftaadu shakhsiyan ku geysaa qeybta diiwaan galinta ee xafiiska magangalinta Qaxootigu (RPD) ee qaabilan ama aad fakis ahaan ugu durtaa isla xafiiska haddii firada waraaqaha aad soo dirayso ay ka yar yihiin 20 xaashiyood, haddii kale waxaad ku soo diri kartaa boostada. Cinwaanka iyo lambarka fakisku ee waraaqaha lagu soo hagaajinayo waxaad ka heli kartaa qeybta Hagaha Dalbadaha (*Claimant's Guide*).

4 - **Maalinta qeybta "Hadii foomkaaga ku magaacoban Basis of Claim aanu soo gaadhin xafiiska wakhtigii laguu cayimay":** hadii aanu Xafiiska Magangalinta Qaxootigu (RPD) helin foomkaaga ah *Basis of Claim Form* wakhtiga la cayimay ee ah (15 maalmood kadib maalintii uu ku soo gaaray), waxaa lagaa rabaa inaad tagto dhageysiga khaaska ah ee dacwadaada dalabka qaxootinimo adigoo lagaa rabo inaad shuruudahan hoose buuxiso:

- Waa inaad joogtaa goobta dhageysiga dacwada markey saacaddu tahay 9 subaxnimo (a.m.) maalintii iyoo goobtii laguu qabtey sida ku xusan Ogeysiiska Araga (Notice to Appear).
- Marka la dhageysanayo dacwadaada khaaska ah waxaa lagaa rabaa inaad sheegto sababta Xafiiska Magangalinta Qaxootiga (RPD) ad ugu soo diriweydey wakhtigii lagaa rabay.
- Haddii lagu waayo oo aad soo xaadiriweydo dhageysiga dacwadaada khaaska ah waxa macquul ah in xafiiska RPD uu xidho dacwadaada oo uu ku tilmaamo inaad ka talo baxdey isagoo xafiiska ku soo ogeysiin ama kula soo xidhiidhin.
- Haddii xafiiska RPD uu arko inaad ka talo baxdey dalabkaagii, laguuma ogolaan doono inaad sii waddo dacwadaada sidoo kalena laguuma ogolaan doono inaad furto ama sameyo dalab dacwad cusub.

MACLUUMAAD KALE OO MUHIIM AH

Cinwaanka lagaa la soo xidhiidhayo: Haddii aadan siin Xafiiska Jinsiyada iyo Socdaalka (Citizenship and Immigration Canada) cinwaanka Kanada gudaheeda lagaala soo xidhiidhayo ama Wakaalada Adeega Xuduudaha Kanada (Canada Border Services Agency) markaad dalabka sameynaysey waa inaad u gudbisaa cinwaankaaga xafiiska RPD iyo waliba CIC ama RDP iyo waliba CBSA (hadba kii u soo gudbiyey dalabkaaga RPD) mudoo aan ka badneyn 10 maalmood gudahood laga bilaabo markii aad heshey Ogeysiiska Aragga ee dhageysiga dalabkaaga (*Notice to Appear for a Hearing*). Waliba waa inaad qoraal ahaan ugu sheegtaa xafiiska RPD **yo** CIC ama CBSA sida ugu dhakhsaha badan, haddii cinwaankaaga ama telefoonkaagu isbadalo. Haddii aad sidaa yeeli weydo oo aadan u soo gudbin xafiiska RPD meesha iyo sida laguula soo xadhiidhayo, waxaa laga yaabaa in xafiiska RPD u aqoonsado codsigaaga inaad ka talo baxdey oo uu xidho dalbkaaga.

La Taliye: haddii ad go'aansato inaad u baahantahay la taliye ku caawiya marka la dhageysanayo dacwadaada:

- haddaba marka aad qabsato, ijaarato ama iska baddasho la taliye waa inaad sida ugu dhakhsaha badan xafiiska RPD **yo** CIC ama CBSA (hadba kooda dalabkaaga u gudbiyey RPD) qoraal ahaan ugu gudbisaa magaca la taliyahaaga, cinwaankiisa, lambarka telefoonkiisa, fakiskiisa iyo emailkiisa. Haddii la taliyahaaga uu yahay xubin ka tirsan ururada garyqaanada gobalada (provincial law society), Rugta Garyaqaanada ee Kubeek, ama La Taliyaasha Socdaalka ee Golaha Hawl-Toosinta Kanada, waxaa kale oo lagaa rabaa inaad soo gudbiso magaca ururka ay ka tirsanyihin iyo lambarka xubinimadooda ururka.
- haddii aad iska badasho la taliye, waxaa mas'uuliyadaada ah inaad xaqijjiso in la taliyaha cusub ee aad qabsato ama ijaarato inuu gacanta ku dhigo dhammaan dokumentiyada la xiriira isla markaana kaabaya dacwada dalabkaaga. Wuxaan ku jira dukumentiyada adiga, RPD ama cid kale haddii ay jirto aad u gudbiseen lataliyahaagii hore.

Arjiga iska baddalida maalinta iyo wakhtiga (aminta) dhageysiga dalabkaaga: haddii aad rabto inaad iska baddasho maalinta ama wakhtiga (aminta) dhageysiga dalabkaaga, waa inaad si degdeg ah qoraal ahaan ugu codsataa.

- Haddii aad rabto macluumaad dheeri ah oo ku saabsan sida loo sameeyo dalabka, eeg Hagaha Dalbadaha (*Claimant's Guide*) iyo xeerka 50 iyo 54 ee Qeypta Xeerarka Magangalinta Qaxootiga (*Refugee Protection Division Rules*).
- Xafiiska RPD waa inuu helaa arjigaaga ugu yaraan saddex bari oo ah maalmaha la shaqeeyo ka hor maalinta loo cayimay dhageysiga dacwadaada dalabka, inay jiraan duruufo caafimaad ama arrimo kale oo deg-deg ah ma ahee.
- Haddii sababta aad u badaleyso maalinta dhageysiga dacwadaada ay tahay duruufo caafimaad, waa inaad kusoo lifaaqdaa cadeymaha caafimaadka ee keenay arrinta baddalka maalinta arjigaaga. Fahfaahin la xidhiidha macluumaadka laga rabo iney ku qorraadaan caddeynta caafimaadka ee lagaa rabo, waxaad ka heli karta Hagaha Dalbadaha (*Claimant's Guide*).
- Haddii aad nusqad caddeynta caafimaadka ku soo lifaaqdo arjigaaga waa inaad caddeynta caafimaad asligeeda si dhakhso ah ugu guddisaa RPD.
- Xafiiska RPD waxa kaliya oo uu waafaqi karaa inuu kaa baddalo maalinta dhageysiga dalabkaaga haddii kaliya ay jiraan duruufo qeyracaadi ah. Sida haddii aad tahay qof duruuf ahaan jilicsan oo u baahan in gabbaad la siiyo iyo haddii ay jiraan arrimo degdeg ah ama dhacdo kugu keentey arrimo kaa tan weyn adiguna aad isla markaa isku deydey wixii tabartaa ah sidii aad u sii wadi lahayd dalbkaaga.
- **Waxa kaliya oo badali kara maalinta iyo wakhtiga dhageysiga dacwadaada dalabka xafiiska RPD. Haddii aynan RPD kugu wargalin waxa kale ee aad sameyn lahay, waa inaad soo xaadirtaa dhageysiga dacwadaada maalinta iyo wakhtiga laguu qabtey ee ku qoran Ogeyssiska Muuqaaga.**
- **Haddii aad soo xaadiri weydo dhageysiga dacwadaada, xafiiska RPD wuxuu kuu aqoonsanayaa inaad dalabkaagii ka tanaasushay wuxuuna xidhayaa dalbkaaga.**

Arjiga codsiga in lagaa baddalo goobta lagu dhageysanayo dalabka dacwadaada: Haddii aad rabto inaad iska baddasho goobta lagu dhageysanayo dacwadaada, waa inaad qoraal ahaan u soo gudbisaa sida ugu dhakhsaha badan.

- Haddii aad rabto macluumaad dheeri ah oo ku saabsan sida loo dalbado eeg Hagaha Dalbadaha (*Claimant's Guide*) iyo xeerka 50 iyo 53 ee Qeypta Xeerarka Magangalinta Qaxootiga (*Refugee Protection Division Rules*).
- Waa in xafiiska RPD uu helaa arjigaaga ugu yaraan 20 maalmood ka hor maalinta loo qoondoyey in la dhageysto dalabka dacwadaada.
- Haddii aad codsato inaad iska baddasho goobta lagu dhageysanayo dacwadaada balse aadan helin jawaab arrintaa la xidhiidha, waxaa lagaa raaba inaad tagto meesha ku cad Ogeyssiska Muuqaaga una diyaar ahaataa dhageysiga dacwadaada.
- Xafiiska RPD sida kaliya ee uu ku badali doono goobta dacwada lagu dhageysanayo ayaa waxay tahay haddii ay sababta loo badalayo ku saleysan tahay wax la taaban karo, iyadoo laga shidaal qaadanayo shuruudaha ku taxan xeerka 53 isla markaasna laga heli karo Hagaha Dalbadaha (*Claimant's Guide*).




Luuqadda turjumidda: Haddii aad rabto inaad iska baddasho luuqadda ama lajhada turjumida ee aad horey u doortey markii faylkaaga loo gudbiyay xafiiska RPD ama intaa ka dib ku jira foomkaga *Basis of Claim*, waxaa shardi ah inaad RPD qoraal ahaan ugu soo gudbiso.

- Ku soo caddee luuqadda ama lajhada cusub ee aad rabto in la tarjumo.
- Waana inuu xafiiska RPD helaa ogeysiiska arrintan ugu yaraan 10 maalmood ka hor maalinta loo qoondeyey dhageysiga dacwadada.

Fariinta ayaa kuu sheegi doonta inaad wacco lambar telefoon oo ku yaala ogeysiiska si aad u heesho cinwaanka saxda ah ee goobta lagu qabanayo dhageysiga dacwada dalabkaaga qaxootinimo ee kowaad iyo waliba dhageysiga aan caadiga ahayn (dhageysiga labaad) ee kor ku cad.
